II. Updates/Announcements

A. PRIDE

- i. Sarah attended the EPC meeting and stated it went well. The faculty will be including the gender inclusive language in the syllabi.
- ii. One of the concerns were that the faculty felt there hasn't been enough training to answer questions regarding this matter
- iii. Sarah expressed that they are willing to collaborate with professors regarding the training piece. They have facilitated several trainings regarding gender inclusive language.
- iv. The gender inclusive language may be included for the summer.

B. OBSWS Re: Black History Month

- i. Bree'Ana expressed that UCONN did not give Black History month much recognition till 2/14.
- ii. Bree'Ana stated that she felt it was a disservice to students of color at the university and the university should have put in more efforts.
- iii. 50% of student body are students of color and they too should feel validated
- iv. GSO co-chairs wrote a letter to dean and associate dean expressing their concerns regarding the lack of Black History month programing.
- v. A committee was supposed to plan some events for Black History month, but it seems as if it was not a priority and someone dropped the ball.

A. Co-Chairs

- iv. The current co-chairs are thinking of doing recruiting events for their positions
- b. Headshots at Social Workers' Network
- i. The location for the headshots was planned to be in the library but unfortunately there is no space. It will now be held in the SSW Rm G09.
- ii. Emails will be sent out with the information. 38 spots are filled thus far. There are 10 spots remaining.
- c. Human Trafficking
- i. 15-20 people have signed up thus far. Tammy Sneed, the director of DCF will be the training facilitator.
- ii. There will be one more email sent for participants who may still be interested in the training.
